Luncheon speakers are respectfully requested to limit their presentation to twenty (20) minutes, unless the presentation is approved for CLE credit.

**SPONSOR GUIDELINES**

- The SPBC FAWL Membership List is available online for use during the year of sponsorship if a sponsor wishes to email Members (emails cannot be sent by SPBC FAWL on behalf of sponsors);
- Sponsors may display sponsor's own banner at events at an area designated by the SPBC FAWL Board, however, only SPBC FAWL's banners shall be displayed at the front of the room (by the speaker);
- Raffles are permitted at luncheons if for an actual prize (no self-promoting raffles such as discount on sponsor services);
